• SCHOOL TIMETABLE

From 9:00 a.m. to 5:00 p.m.

ARRIVALS AND DEPARTURES

Pupils are dismissed at 5:00 pm. If a pupil needs to leave earlier, they may be collected at the following times:

- Nursery and Infants: 3:30 pm

- Primary: 3:45 pm

- Secondary (ESO): 4:00 pm

Pupils are not allowed to leave school on their own.

Children will not be handed over to unfamiliar individuals without prior authorisation from the family (via Qualla).

Private vehicles are not permitted to park in front of the school building. Please respect neighbours' driveways and access points.

EXTENDED SERVICE

Times:

Morning: from 7:45 a.m. to 8:45 a.m. **Afternoon**: from 17:15 p.m. to 18:30 p.m.

Pupils arriving before 8:45 am or collected after 5:15 pm will join the Extended Hours Service. This takes place in the Early Years building and is billed separately.

This service is managed through the Qualla app.

TRANSPORT

The school offers eleven bus routes, each with specific bus stops.

Pupils are accompanied by a supervisor at all times.

New families must confirm their child's bus route and stop by contacting the school office or by emailing info@saintgeorgeschool.es before September.

The Qualla app will be used throughout the academic year to manage the transport service.

Polite and respectful behaviour on the bus is essential to ensure a safe and pleasant journey for all. Pupils who do not follow the rules may be temporarily or permanently excluded from the service, depending on the seriousness of the incident.

KITCHEN

The school has an on-site kitchen and prepares meals using locally sourced ingredients. All pupils have lunch at school. Menus are available on a monthly basis and are adapted to cater for food intolerances and allergies.

AUTHORISATIONS

Before the start of the academic year, families must complete all required authorisations through the Qualla Family app.

RULES FOR CONDUCT & RESPECT WITHIN THE SCHOOL ENVIRONMENT

With the aim of ensuring a safe, healthy, and respectful environment for all members of the educational community, we would like to remind parents, guardians, and accompanying adults that:

SMOKING PROHIBITION

In accordance with Law 28/2005 on health measures against smoking, as amended by Law 42/2010, smoking is strictly prohibited on school premises, including all entrances, exits, and outdoor areas, even if they are in the open air. This regulation aims to protect the health of children and promote healthy lifestyle habits.

We respectfully ask for your cooperation in maintaining a smoke-free school environment, setting a positive example for pupils and contributing to the wellbeing of the entire school community.

PROHIBITION OF PETS

For reasons of safety, hygiene, and respect for all members of the school community, pets are not allowed on school premises or in the immediate surrounding areas, such as entrances, playgrounds, or waiting zones. This measure is based on principles of prevention and positive coexistence, and takes into account potential allergies, fears, or risk situations for some children.
